



**ISLANDS OFFICIAL

INSTAGRAM and TIKTOK CONTEST 2022 OFFICIAL RULES**

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING.

- 1) HOW TO ENTER:** An Instagram and TikTok account is required to enter (accounts are free). Follow, Like, comment or mention @IslandsBurgers on Instagram and TikTok (the “Contest”) to be entered into the contest. You will receive additional entries for each like, mention or comment that you tag @IslandsBurgers. Entry per person (per Instagram and TikTok account) capped at twenty (20). You must become a follower of @IslandsBurgers Instagram and TikTok account.

- Islands Restaurants, LLC (“**Islands or Sponsor**”) is the official timekeeper.
- Odds of winning will depend on the number of entries received.
- One (1) Winner will be chosen at random.
- The Contest is solely sponsored by Islands. **The Contest is not sponsored, administered or endorsed by Instagram or TikTok (the “Media Entity”).** Void where prohibited.

4) ELIGIBILITY:

- Entrants must be at least eighteen (18) years of age at the time of entry. Entrants must be the rightful owner and **Authorized Account Holder** of the Instagram and TikTok accounts. Entrants must be a legal resident of either California or Arizona. The Winner will be asked to prove both eligibility requirements stated above.

5) PARTICIPANTS: By your participation in the Contest, you agree to be bound by all rules related to the Contest, and (a) you grant to Islands a perpetual, unlimited, non-exclusive, worldwide, royalty-free license to use, copy, print, display, reproduce, modify, publish, post, transmit and distribute the photo/video and any material included in any Instagram or TikTok photo/video you tag as entry into Contest; and (b) you certify that any person pictured in any tagged Instagram or TikTok photo/video (or, if a minor, his/her parent/guardian) authorizes Islands to use, copy, print, display, reproduce, modify, publish, post, transmit and distribute the photo and any material included in such photo; and (c) you agree that Sponsor and the Media Entity shall not be responsible or liable for, and are hereby released from, any and all costs, injuries, losses or damages of any kind, including, without limitation, death and bodily injury, due in whole or in part, directly or indirectly, to participation in the Contest or any Contest-related activity, or from entrants’ acceptance, receipt, possession and/or use or misuse of any prize.

6) RESTRICTIONS:

1. Employees, officers, and directors (including immediate family members, spouses, parents, children, siblings, and their respective spouses) of Islands are not eligible to participate in the Contest.

The Winner will be required to privately provide his or her name, address, age, and other personal information necessary to receive the Prize. The potential Winner may be required to verify ownership of the winning Instagram and TikTok account. The potential Winner must respond to Islands within two (2) days of being declared a potential winner. Failure to respond within two (2) days may result in the potential Winner being disqualified and an alternate Winner selected. A prize will not be awarded until all such properly executed forms are returned.
