



**ISLANDS OFFICIAL

OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING.

- 1) HOW TO ENTER:** An Instagram account is required to enter (accounts are free). Follow, Like, comment or mention @IslandsBurgers on Instagram (the “Sweepstakes”) to be entered into the Sweepstakes. You will receive additional entries for each like, mention or comment that you tag @IslandsBurgers. Entry per person (per Instagram account) capped at twenty (20). You must become a follower of @IslandsBurgers Instagram account.

Another way a participant can enter the Sweepstakes is to mail a legibly handwritten, self-addressed, stamped envelope or postcard to the following address within the Promotion Period: Islands Restaurants ATTN: Marketing Catalina Sweepstakes 5760 Fleet Street, Suite 100, Carlsbad, CA 92008. - 2) PROMOTION PERIOD:** Begins on January 1, 2020 at 12:00 AM until January 31, 2020 at 11:59 pm (PDT).
- 3) PRIZE:** Five (5) Prize winners will be chosen at random from all eligible entries received during the Promotion Period. Each prize winner, once confirmed to be eligible, along with one guest, will receive a two (2) night Catalina package which includes the following details: (a) roundtrip trip for two on the Catalina Express and (b) hotel accommodations for two (2) nights (based on standard room double occupancy rates) at a hotel to be chosen by Islands. Each prize has an estimated cash value of \$600. No substitution, cash redemption or transfer of each prize awarded is allowed.
- 4) GENERAL INFORMATION:**
 - ISLANDS RESTAURANTS, L.P. (“Islands or Sponsor”) is the official timekeeper.
 - Odds of winning will depend on the number of entries received.
 - Five (5) winners will be chosen at random.
 - The Sweepstakes is solely sponsored by Islands. **The Sweepstakes is not sponsored, administered or endorsed by INSTAGRAM (the “Media Entity”).** Void where prohibited.

- You must be at least eighteen (18) years of age, and you must be a legal resident of the fifty (50) United States. Winners will be asked to prove both eligibility requirements stated above.

7) RESTRICTIONS:

8) NOTIFICATION: The potential winners will be notified via Instagram on February 7, 2020 by 11:59 pm. The winner will be required to privately provide his or her name, address, age, and other personal information necessary to receive the Prize. The potential winners may be required to verify ownership of the winning Instagram account. The potential winners must respond to Islands within two (2) days of being declared a potential winner. Failure to respond within two (2) days may result in the potential winner being disqualified and an alternate winner selected. A prize will not be awarded until all such properly executed forms are returned. All federal, state, local, or other tax liabilities, including but not limited to income taxes or like amounts in

connection with a Winner's award, acceptance, or use of a prize arising from this Sweepstakes will be the sole responsibility of the Winner.
